NSW	Travel and Accommodation Allowance is available for Apprentices and New Entrant Trainees who travel more than 120 km (return) to attend day or block release training with their RTO.	Amount advised upon application with Training Services NSW
QLD	Travel and Accommodation Allowance -Apprentices and Trainees who have to travel at least 100km (return) to attend training at the closest training organisation which delivers training in the qualification being undertaken. TAS	Travel assistance is available for Apprentices and Trainees who are required to travel 21km (one way) or more to attend training.
